- Infrastructure Fund ("**Infrafond**") of RVC - 51%

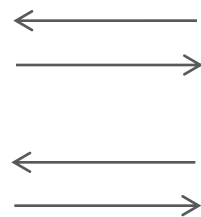
Russian Venture Company (RVC)

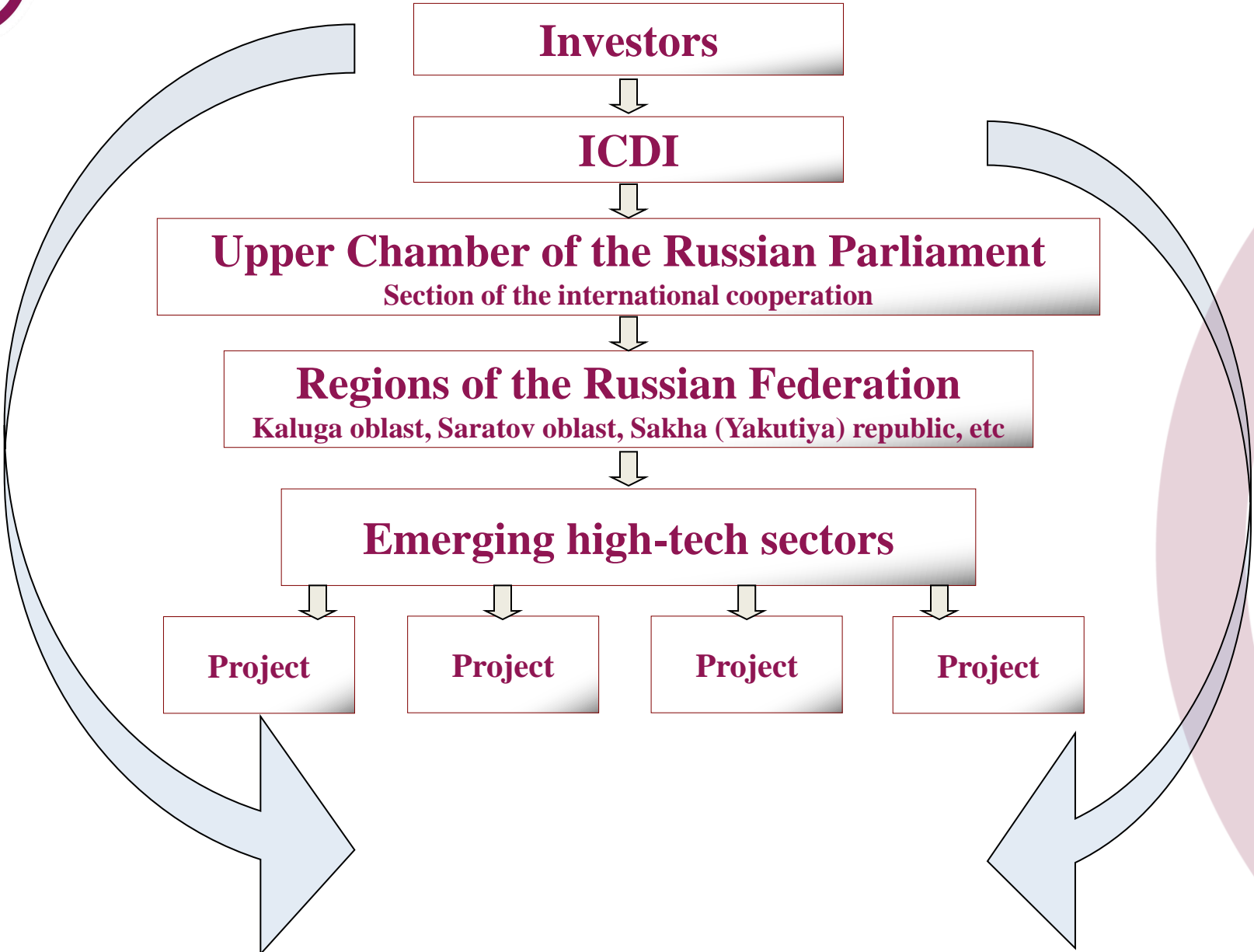

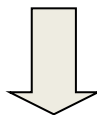
